

The Shop

Our new re-use shop will be open soon at the Llanfoist site!
The shop sells suitable items which have been taken into the Household Waste Recycling Centre by members of the public which otherwise would have been recycled or disposed of.

Items will include wooden furniture, garden ornaments, bric a brac, salvage items, bikes, sports and musical equipment.

Opening hours are 10am-2pm Thursday and Friday (these hours may be extended later in the year).

The shop will be self-funded with any profit being used by MCC to improve re-use services.

We're sorry, items cannot be dropped off direct at the shop, they must be taken to the HWRC where staff will sort items suitable to sell.

If the shop proves successful over the coming months, we plan to open a second shop at our Five Lanes site.

A guide to using the Household Waste Recycling Centres (HWRCs)



Site Facilities

Monmouthshire County Council provides four Household Waste Recycling Centres (HWRCs) for the use of Monmouthshire residents.

Residents must provide proof of residency in order to access the sites.

Monmouthshire County Council will provide one permit free of charge to each household within Monmouthshire to display in the front windscreen of their vehicle on entry to the local site. A current driving licence will also be acceptable should a permit be forgotten.

Our main sites at Llanfoist and Five Lanes accept all types of **household waste**, with our smaller sites at Mitchel Troy and Usk offering more limited facilities due to space restrictions. For a full list of the items you can dispose of at each site please see www.monmouthshire.gov.uk

From 1st June, all sites are open daily from 8am to 5:50pm with the following exceptions:

Llanfoist: Closed on Wednesdays

Five Lanes: Closed on Thursdays

Mitchel Troy: Closed on Mondays and Thursdays

Usk: Closed on Tuesdays and Fridays

Site Rules include...

- **Sites are provided for the use of Monmouthshire residents ONLY.** Permits should be displayed and operatives will turn vehicles away if no proof of address can be provided.
- **Business waste** is not accepted at our Household Waste Recycling Centres. Site operatives will refuse disposal of waste at the HWRCs should they suspect it has originated from a business. Businesses have a responsibility to arrange their own waste collection and disposal. MCC offers a collection service and Viridor offer a pay per weight facility at Llanfoist and Five Lanes.
- **DIY waste** is restricted to five bags or a small car boot load per visit with a maximum of two visits per month. For larger amounts, a skip or a registered waste contractor should be hired. Alternatively a pay per weight facility is offered by Viridor at both the Llanfoist and Five Lanes sites.
- **Commercial type vehicles** carrying domestic waste (vans, 4x4 pick-ups, sign written vehicles, trailers over 4ftx6ft) are not allowed entry into the HWRCs without a 'Van/trailer' permit. If your only vehicle is a commercial type vehicle listed above and is **NOT** used for business purposes, you can apply for a permit to allow for the disposal of domestic waste.
- We take the **welfare of our site staff and our residents** seriously and believe they are entitled to a safe environment, free from abusive behaviour. Any incident of this nature will be reported to the police and regulatory authorities.
